All parties are directed to call the announcement line 770-822-7529 every day after 5:00 p.m. beginning **October 25, 2024**, until excused by the Court, to hear a recorded list of cases being called in. The Defendant must appear in court when directed. Failure to appear as directed could result in a bond forfeiture and issuance of a warrant for the arrest of the Defendant. The bondsman is not required to appear.
