As well, any attorney or defendant who wishes to appear in person may do so. Admittance to the courtroom will be pursuant to current health department guidelines and seating will be properly limited.


**JURY TRIALS**

All continuances must be approved by the Court. Written requests for continuance must be received by the Court at least five (5) days prior to the scheduled appearance date.
