A non-jury term of the Gwinnett Superior Court will begin *April 17, 2020* at 9:00 a.m., in Courtroom 3-D, at which time the cases appearing on the within calendar will be called for trial in the order in which they are listed hereon. This calendar is set for the trial of non-jury cases only. UNCONTESTED cases will be called at 9:00 a.m. Cases in which no appearance is made will be considered abandoned and will be DISMISSED FOR WANT OF PROSECUTION. If your case is completely resolved and ready for final adjudication, your court appearance can be avoided and your case finalized through filing of a MOTION FOR JUDGMENT ON THE PLEADINGS. A motion for Judgment on the Pleadings is an option only available to attorneys. Parties representing themselves must attend the scheduled court hearing. Counsel/Parties SHOULD HAVE A FINAL DECREE PREPARED and ready to present at the trial of your case.

On JANUARY 1, 2007, Georgia's new Child Support guidelines went into effect. The new law applies to **ALL** child support decisions made after January 1, 2007. The parties/attorneys involved in these types of cases **MUST** submit the Georgia Child Support Worksheet and the accompanying Schedules to the Court before the trial date noted on the attached calendar.

You can obtain manual versions of the Worksheet and Schedules from the following website, or you can calculate your child support amount on the electronic calculators (worksheets) also provided on the same website. After completing the Worksheet and Schedules, you should print these documents and bring a copy of them with you when you appear in Court .

IF YOUR CASE WAS ON A PREVIOUS CALENDAR AND WAS ANNOUNCED SETTLED, YOU ARE REQUIRED TO APPEAR ON APRIL 17, 2020, UNLESS YOU FILE ALL NECESSARY DOCUMENTS AND SUPPLY A FINAL ORDER FOR ENTRY PRIOR TO THE CALL OF THIS CALENDAR. CASES IN WHICH NO APPEARANCE IS MADE WILL BE CONSIDERED ABANDONED AND WILL BE DISMISSED FOR WANT OF PROSECUTION.
