Georgia DOT has posted information related to the pedestrian improvement project at <http://www.dot.ga.gov/AboutGDOT/PublicOutreach>.

This project proposes to install a raised median from southeast of US 23/5R 13/Burford Highway to Price Place, from Price Place NW to Light Circle NW/Alston Trace, and from Light Circle NW/Alston Trace to Light Circle NW to limit excess crossing movements along the corridor. Left turn lanes would be installed at Price Place NW, Light Circle NW/Alston Trace, and Light Circle NW. Americans with Disabilities Act (ADA) ramps and crosswalks would be updated and/or added to side streets as needed. An offsite detour would not be needed. The project is expected to be completed within 6 months.

The purpose of this internet posting is to replace an in-person meeting while allowing the public to review the proposed project, provide feedback, or write in with questions.
