This means that you will not have the right to visit, contact, or have custody of your child (ren) or make any decisions affecting, your child(ren) or affecting your child(ren) or your child(ren)s earnings or property. Your child(ren) will be legally freed to be adopted by someone else

Even if your parental rights are terminated: You will still be responsible for providing financial support (child support payments) for your child(ren)s care unless and until your child(ren) is/are adopted; Your child(ren) can still in herit from you unless and until your child(ren) is/are

This is a very serious matter. You should contact an attorney immediately so that you can be prepared for the court hearing. You have the right to hire an attorney and to have him or her represent you.
