O.C.G.A. §15-11-310.

At the hearing held for the purpose of reviewing the determination by the court that the reunification plan is not appropriate, the court shall determine by clear and convincing evidence whether reasonable efforts to reunify the child(ren) and their family will be detrimental to the child(ren) and that reunification services, therefore, should not be provided or should be terminated. There shall be a presumption that by clear and convincing evidence that: (1) The parents have unjustifiably failed to comply with a previously ordered plan designed to reunite the family; (2) a child has been removed from the home on at least two previous occasions and reunification services were made available on these occasions; or (3) Any of the grounds for terminating parental rights exist, as set forth in subsection (a) and (b) of O.C.G.A. §15-11-310. You are further notified that a hearing thereon will be held before this court on **20th day of December, 2022 at 9:00 am.** You are required to appear and answer the allegations of the petition at said hearing.
