If you do not file an answer, Georgia law provides that you can permanently lose any presumption of claim to rights as a parent regarding Petitioner's two minor children. If you fail to appear, the court can declare that you are not the biological and legal father of these two minor children in your absence. If the court at trial finds that the facts set out in the petition to end the legal relationship between you and Petitioner's minor children are true and that the declaration that you are not the biological and legal parent will serve the best interests of the minor children, the court can enter a judgment declaring that you are not the biological and legal parent and overcoming any presumption. If the judgment does so, you will no longer have any rights regarding the minor children. This means that you will not have the right to visit, contact, or have custody of the minor children or make any decisions affecting the minor children or their earnings or property. The minor children will be legally freed to be legitimized or adopted by someone else with Petitioner's consent.

This is a very serious matter. You should contact an attorney immediately so that you can be prepared for the court hearing. You have the right to hire an attorney and to have him or her represent you. Whether or not you decide to hire an attorney, you have the right to attend the hearing of your case, to call witnesses on your behalf, and to question those witnesses brought against you.
